I the undersigned, being a natural person of legal age, do hereby desire to form a corporation under the laws of the State of Florida and do hereby adopt the following articles of incorporation.

ARTICLE I
NAME

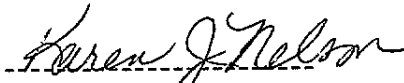

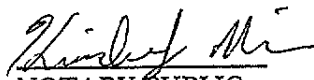
