# ARTICLES OF INCORPORATION

ITSECUR, INC. The undersigned incorporator, for the purpose of forming a corporation under the Business Corporation Act, does hereby adopt the following Articles of cration: Florida Business Corporation Act, does hereby adopt the following Articles of

Article 1. Name. The name of the Corporation shall be: ITSecur. Inc.

These restrictions are intended to preserve exemptions under federal and state securities laws, to provide for orderly changes in ownership of shares, and to serve other reasonable purposes.

Article 12. Rights of Initial Directors. Each of the initial Directors shall have the right to be a Director of the Corporation as long as that respective Director is a Shareholder of the Corporation.
