I the undersigned, being a natural person of legal age, do hereby desire to form a corporation under the laws of the State of Florida and do hereby adopt the following articles of incorporation.

**ARTICLE I
NAME**

The name of the corporation shall be Covenant Montessori Schools International Inc.

GENERAL NATURE OF BUSINESS**

The general nature of business to be transacted by this corporation is:
