ARTICLE I: NAME

The name of the corporation is: Detail Doctor, Inc.

ARTICLE II: NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is to do all things which natural persons might lawfully do in the premises as follows: Automobile washing, waxing, detailing and related products and services and investments of every kind, nature and description.

ARTICLE III: CAPITAL STOCK

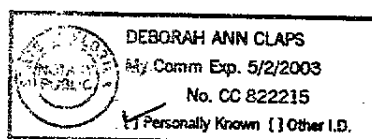


