ARTICLES OF INCORPORATION

SECRETARY OF STATE
TALLAHASSEE, FLORIDA

OF

J. SOUSA ENTERPRISES, INC.

BY THESE ARTICLES OF INCORPORATION the incorporator forms a corporation for profit under Florida law.

1. NAME. The name of the corporation is J. SOUSA ENTERPRISES, INC.

2. TERM. The corporation shall exist perpetually. Corporate existence shall begin when these articles are filled with the Department of State.

3. PURPOSE. The purpose of this corporation is to transact any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.

4. CAPITAL STOCK. This corporation is authorized to issue 100 shares of common stock of a par value of \$1.00 per share. The board of directors may dispose of the authorized but unissued stock from time to time, but every shareholder may purchase his prorata share, as near as can be done without the issuance of fractional shares, on the sale for cash of any previously unissued or new stock of this corporation at the same price at which it is offered to others.

5. REGISTERED AGENT. The initial registered agent for this corporation is John T. Chandler, and the initial registered office is located at 900 Virginia Ave, Ste. 7, Fort Pierce, FL 34982.

6. CORPORATE ADDRESS. The corporation's initial principal office is located at 900 Virginia Ave, Ste. 7, Fort Pierce, FL 34982 and the mailing address is the same.

7. DIRECTORS. This corporation shall have one director initially. The number of directors shall be fixed by the bylaws.

8. INITIAL DIRECTORS. The name and address of the first board of directors, who shall hold office until the first annual meeting of stockholders, is Jessica Lind, 900 Virginia Ave, Ste. 7, Fort Pierce, FL 34982.

9. INCORPORATOR. The name and address of the incorporator is Jessica Lind, 900 Virginia Ave, Ste. 7, Fort Pierce, FL 34982.

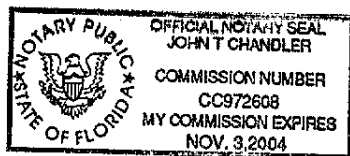
