The undersigned incorporator to these Articles of Incorporation, an natural person competent to contract, for the purpose of forming a corporation under the laws of the State of Florida, does hereby adopt the following Articles of Incorporation:

Article 1 Name of Corporation

The name of the corporation is J.E.D. REALTY GROUP, INC.

Article 2 Principal Office
