

The undersigned, for the purposes of foregoing a corporation under the Florida General Corporation Act, do hereby adopt the following articles if incorporation.

ARTICLE I  
Corporate Name & Address

The name of the corporation shall be NALA of Broward, Inc.. and the address is 3863 NW 35<sup>th</sup> Street Coconut Creek, Fl 33066.

ARTICLE II  
Term of Existence

The duration of the corporation is perpetual, to be commenced with the filing of these articles of incorporation with the Department of State of the State of Florida.

ARTICLE III  
Nature of Corporate Business

The general purpose for which the corporation is organized is:

1. to engage in a framing sales & service establishment and to do that which is incidental to the foregoing in order to accomplish the foregoing; and

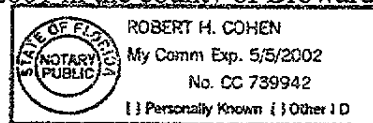


