ARTICLE VII

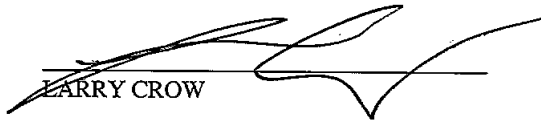
MANAGEMENT OF BUSINESS

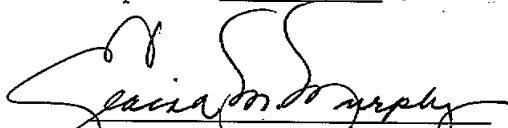

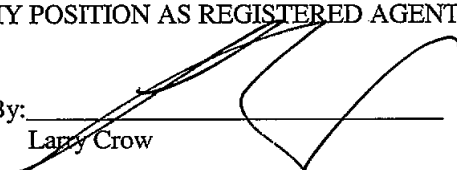
