PREEMPTIVE RIGHTS IN PROPORTION TO SHARES

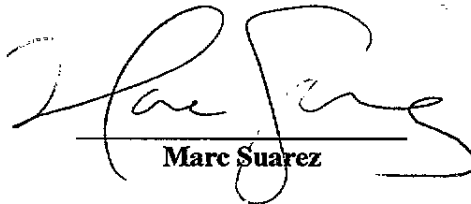
