Article 1

The name of this corporation is **Toly Trading Corporation**

Article 2

The corporation may engage in any and all lawful businesses for which corporations may be incorporated under Chapter 607, Florida Statutes. While pursuing its purposes, the corporation may exercise the powers granted now or in the future by Section 607.0302, Florida Statutes, and by common law.

Article 3

The aggregate number of shares which the Corporation shall have the authority to issue shall be 20,000,000 shares of common stock, each having a par value of \$.001.

Article 4

The street address of the place of business of the Corporation is 5817 21st Avenue South, Gulf Port, Florida 33707. The address of the initial registered office maintained pursuant to Section 607.0501 Florida Statutes is 5817 21st Avenue South, Gulf Port, Florida 33707. 
Article 7

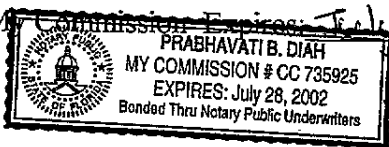
