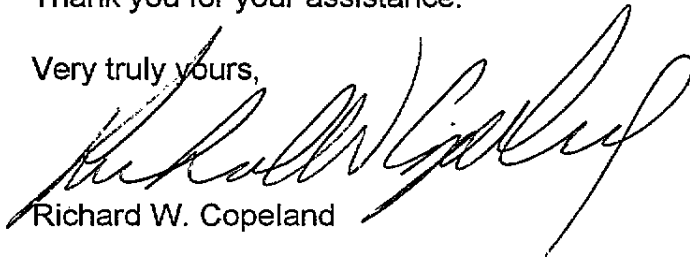

Article I- Name

The name of this corporation is **CompuChild of Central Florida, Inc.**

Article II-Duration

This corporation shall exist into perpetuity unless sooner dissolved by law and commencing with the date of **filing of these Articles of Incorporation with the Department of State.**
