ARTICLES OF INCORPORATION OF LIGHTHOUSE POINT NEWS, INC.

ARTICLE I - NAME

The name of this corporation is Lighthouse Point News, Inc.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.
