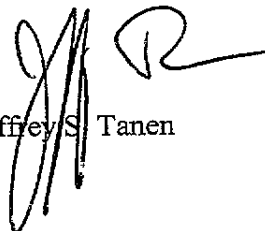

Name of Corporation

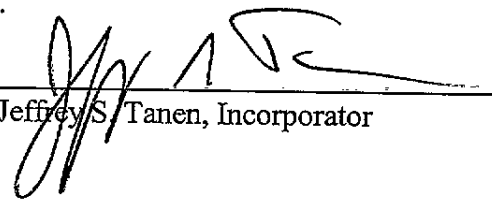

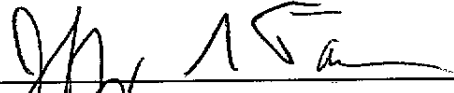
