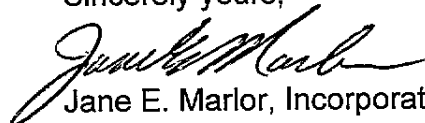

Ability in Motion, Inc. is the name of this Corporation.

### ARTICLE II. - PRINCIPAL OFFICE

The principal office of the corporation is 37033 State Road 54 West, Zephyrhills, Florida 33541.
