ARTICLES OF INCORPORATION

OF

O1 JUL 13 AH II: 27 SECTLANDED STATE TALLAHASSEE, FLORIDA

HESTER AIR SERVICE, INCORPORATED

Article I - Name

The name of this corporation is HESTER AIR SERVICE, INC.

Article II - Address

The mailing address of the principal office of this corporation is 2502 West 10TH Street, #B, Panama City, Florida 32401.

Article III - Duration

This corporation shall exist perpetually commencing on the date of the execution and acknowledgment of these Articles.

Article IV - Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

Article V - Capital Stock
