The number of authorized shares of stock is 1,000 with par value of \$1.00.

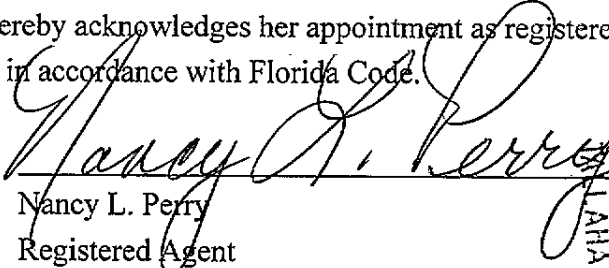

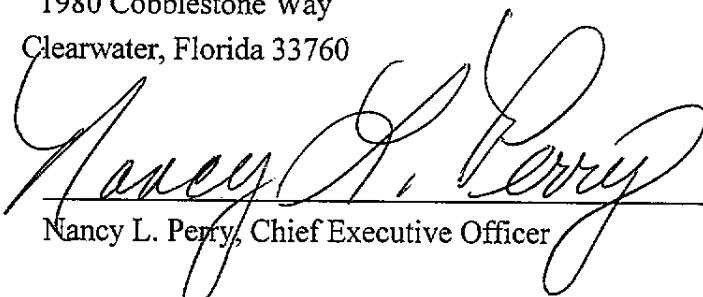
