ARTICLES OF INCORPORATION

OF

THUNDERDOME PRODUCTIONS, INC.

The undersigned, being of legal age and desiring to form a corporation (hereinafter referred to as the "Corporation") pursuant to the provisions of the Florida Business Corporation Act, as amended (such Act, as amended from time to time, is hereinafter referred to as the "Act"), executes the following Articles of Incorporation.

ARTICLE !

<u>Name</u>

The name of the Corporation is Thunderdome Productions , Inc.

ARTICLE II

<u>Address</u>

The principal place of business and mailing address of the corporation is:

325 Jasmine Road Casselberry, FL 32707

ARTICLE III

Purpose and General Powers

The general purpose of this corporation shall be the transaction of any or all lawful business for which corporations may be incorporated under the Act. This corporation shall have all of the powers enumerated in the Act and all such other powers as are not specifically prohibited to corporations for profit under the laws of the State of Florida.

ARTICLE IV

Capital Stock

A. Number and Class of Shares Authorized: Par Value

The aggregate number of shares which the Corporation shall have authority to issue is 10,000 shares of common stock having a par value of \$1.00 per share, which shall be designated "Common Stock."

B. <u>Voting Rights</u>

The Common Stock shall posses and exercise exclusive voting rights and at all meetings of the shareholders each record holder of such stock shall be entitled to one vote for each share held. Shareholders holding Common Stock shall be entitled to one vote for each share held. Shareholders holding Common Stock shall have no cumulative voting rights in any election of Directors of the Corporation.

C. <u>No Preemptive Rights</u>

No holder of shares of any class of the capital stock of the Corporation shall have as a matter of right any preemptive or preferential right to subscribe for, purchase, receive, or otherwise acquire any part of any new or additional issue of stock of any class, whether now or hereafter authorized, or any bonds, debentures, notes, or other securities of the Corporation, weather or not convertible into shares of stock of the Corporation.

ARTICLE V

Initial Registered Office and Agent: Principal Place of Business

The initial registered office of this Corporation shall be located at the City of Casselberry, County of Seminole and State of Florida, and its address there shall be, at present, 325 Jasmine Road, Casselberry, Florida 32707, and the initial registered agent of the Corporation at that address shall be Josue Aguilar. The Corporation may change its registered agent or the location of its registered office, or both, from time to time without amendment of these Articles of Incorporation. The principal place of business and the mailing address of the Corporation shall be: 325 Jasmine Road, Casselberry, Florida 32707.

ARTICLE VI

Initial Board of Directors
