ARTICLES OF INCORPORATION

OF

Southern Cross Beach Services, Inc.

THE UNDERSIGNED SUBSCRIBER TO THESE ARTICLES OF INCORPORATION HEREBY SUBSCRIBES TO AND FORMS A CORPORATION FOR PROFIT UNDER THE LAWS OF THE STATE OF FLORIDA.

ARTICLE I - NAME

THE NAME OF THE CORPORATION IS Southern Cross Beach Services, Inc..

ARTICLE II - PURPOSE OF BUSINESS

THIS CORPORATION IS ORGANIZED FOR THE PURPOSE OF TRANSACTING ANY OR ALL LAWFUL BUSINESS PERMITTED UNDER THE LAWS OF THE UNITED STATES AND FLORIDA.

ARTICLE III - DURATION

THIS CORPORATION SHALL EXIST PERPETUALLY COMMENCING ON THE DATE OF EXECUTION OF THESE ARTICLES.

ARTICLE IV - CAPITAL STOCK

THIS CORPORATION IS AUTHORIZED TO ISSUE 100 (ONE HUNDRED) SHARES OF COMMON STOCK, EACH SHARE HAVING THE PAR VALUE OF \$ 1.00 (ONE DOLLAR).

ARTICLE V - PREFERENCES, LIMITATIONS AND RELATIVE RIGHTS OF SHARES OF CAPITAL STOCK.

VOTING RIGHTS: EXCEPT AS OTHERWISE PROVIDED BY LAW, THE ENTIRE VOTING POWER FOR THE ELECTION OF DIRECTORS AND FOR ALL OTHER PURPOSES SHALL BE VESTED EXCLUSIVELY IN THE HOLDER OF THE OUTSTANDING COMMON STOCK.

ARTICLE VI - PRE-EMPTIVE RIGHTS

THE SHAREHOLDERS OF THE CORPORATION SHALL HAVE THE PREEMPTIVE RIGHT TO ACQUIRE UNISSUED OR TREASURY SHARES OF THE CORPORATION IN PROPORTION TO THEIR RESPECTIVE PERCENTAGES OF STOCK OWNERSHIP AT THE PRICE AT WHICH IT IS OFFERED TO OTHERS.


