ARTICLES OF INCORPORATION
OF

ARTICLE I. NAME

The name of the corporation is MERRILL BRAVER QUINTERO, P.A.

ARTICLE II. DURATION AND COMMENCEMENT OF EXISTENCE

The corporation is to have perpetual existence, commencing at the filing of these articles with the Department of State.

ARTICLE III. PURPOSE

The corporation is organized for the purpose of transacting any and all lawful business. Specific in the practice of law.

ARTICLE IV. CAPITAL STOCK

The stock in the corporation shall be issued pursuant to the provisions of Section 1244 of the Internal Revenue Code.

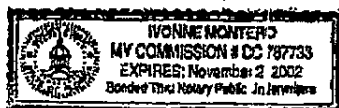
