ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation, a natural person recompetent STATE Contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

Name of Corporation

The name of this corporation shall be: The Lending Place Inc.

ARTICLE II

Nature of Business

The general nature of the business to be transacted by this corporation is: to sell and provide mortgage services and processing via direct, indirect and/or electronic means as well as any other activities of business permitted under the laws of the United States and the State of Florida.

ARTICLE III
