**ARTICLES OF INCORPORATION  
OF  
BIZZIE BODIES, INC.**

The undersigned natural person, competent and licensed to conduct business in the State of Florida, for the purpose of forming a Professional Service Corporation for profit under the provisions of Chapter 607, Florida Business Corporation Act, and Chapter 621, Florida Professional Service Corporation Act, of the Florida Statutes, does hereby adopt the following Articles of Incorporation.

**ARTICLE I  
NAME OF CORPORATION, PRINCIPAL OFFICE AND  
MAILING ADDRESS**

The name of the corporation shall be BIZZIE BODIES, INC. The principal office of the corporation shall be 6280 Chinquapin Road, Milton, FL 32570, and the mailing address of the corporation shall be the same.

**ARTICLE II  
PURPOSES**

The purpose or purposes for which the corporation is organized is for the provision of conducting personal shopping services for the public in the State of Florida and to transact all lawful business for which corporations may be organized under the Florida Professional Services Corporation Act.

**ARTICLE III  
CAPITAL STOCK**

- a. The maximum number of shares of stock that the corporation is authorized to have outstanding at any time shall be 100 shares of common stock at ONE DOLLAR (\$1.00) per share par value.

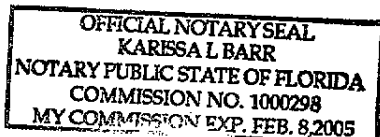

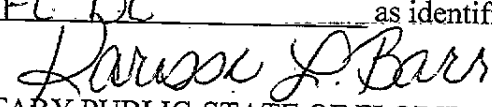

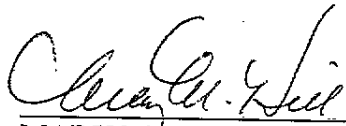
