The undersigned incorporator makes, subscribes, acknowledges and files with the Florida Department of State these Articles of Incorporation for the purpose of forming a Florida corporation pursuant to the Florida Statutes, Chapter 607.

ARTICLE I.

NAME

The name of this corporation is Knowledge Edge, Inc.

ARTICLE II.

DURATION

This corporation shall have perpetual existence until dissolved according to law.

ARTICLE III.

PURPOSE

The purposes for which this corporation is organized is for the transaction of any and all lawful business for which a corporation may be organized under Florida Statute 607.

ARTICLE IV.

CAPITAL STOCK

This corporation is authorized to issue 100,000 shares of One Dollar (\$1.00) par value common stock.

INDEMNIFICATION


The Corporation may indemnify any officer or director, or any former officer or director to the full extent permitted by law.




