**ARTICLES OF INCORPORATION
OF
PRIMARIUS GROUP, INC.**

ARTICLE I - NAME

The name of the corporation shall be Primarius Group, Inc. (hereinafter, the "*Corporation*" or the "*Company*").

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE VI - BOARD OF DIRECTORS

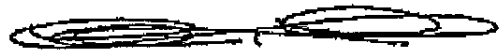
The initial board of directors of the Corporation shall consist of two directors whose names and addresses are as follows:

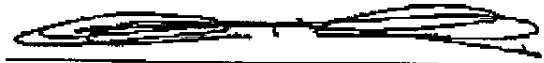
