## ARTICLES OF INCORPORATION

### ARTICLES OF INCORPORATION OF Dade First Initiative, Incorporated

The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, do hereby adopt the following articles of incorporation:

#### ARTICLE ONE

##### NAME

The name of the corporation is Dade First Initiative, Incorporated

#### ARTICLE TWO

##### CORPORATE DURATION

The duration of the corporation is perpetual.

#### ARTICLE THREE

##### PURPOSE OR PURPOSES

The general purposes for which the corporation is organized are:

1. To engage in the business of providing medical supplies to the general public.
2. To engage in any other trade or business that can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.
3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

#### ARTICLE FOUR

##### CAPITALIZATION

The aggregate number of shares which the corporation is authorized to issue is 10,000. Such shares shall be of a single class, and shall have a par value of One Cent (\$0.01) per share.

#### ARTICLE FIVE

##### REGISTERED OFFICE AND AGENT

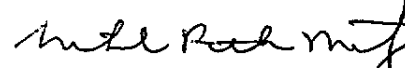
