The undersigned represents Hallmark Leasing, Inc. as registered agent.

I just became aware that the above referenced corporations are listed as delinquent, for failing to timely file the 2002 Uniform Business Report. It is my understanding that the Uniform Business Reports, sent by the Department of State, to my former office at 300 Northwest 82nd Avenue, Suite 412, Plantation, Florida 33324 were returned to your office as "legal mail not forwarded". This "nonforwarding" of the Uniform Business Reports resulted in my office not being able to forward the original Uniform Business Reports to the corporations for timely filing. This failure of the post office has resulted in my clients now being responsible to pay an additional late charge of \$450.00. This is unfair to my clients. This office filed a "forwarding statement" with the post office in November 1, 2001. All mail, including third class mail, has been consistently forwarded to the new address. The only mail which was not forwarded was the initial Uniform Business Report provided by your office.
