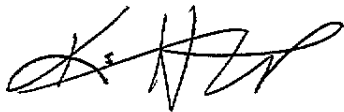

The undersigned incorporators, desiring to form a corporation for profit pursuant to the Florida Business Corporation Act, adopt the following Article of Incorporation:

ARTICLE 1 – NAME OF CORPORATION

The name of the corporation shall be **Ked Management, Inc.**

ARTICLE II – TERM OF EXISTENCE

The corporation shall begin its corporate existence as of the filing of these Articles of Incorporation and shall exist perpetually.

ARTICLE III – GENERAL PURPOSES

The general purposes for which the corporation is organized shall be to provide consulting and management services. It is intended that the corporation is organized for and may conduct and transact any and all lawful business authorized and not prohibited by the Florida Business Corporation Act, as the same may be, from time to time, amended.

ARTICLE IV – CAPITAL STOCK

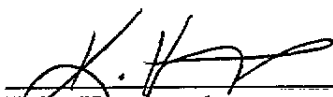
The maximum number of shares of capital stock that the corporation is authorized to issue and have outstanding is One Thousand (1,000), which shall be designated Common Shares with a stated value of one dollar (\$1.00) per share.

The principal office of the corporation in the state of Florida is 15658 Jupiter Farms Road, Jupiter, Florida 33478.

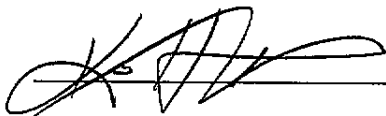
ARTICLE IX – AMENDMENT TO ARTICLES

These Articles of Incorporation may be amended in any manner permitted by law.

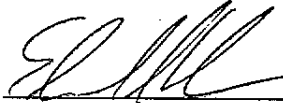
ARTICLE X – INDEMNIFICATION
