I recently spoke with someone on the phone and was told that my corporation has been dissolved. From my understanding, a letter was sent to me that needed to be signed and returned to your office, and I am very sorry, but I did not receive that letter. I am not making any excuses, but I have been living in an abusive marriage for the past 2 years. It has been very emotionally draining and my business has suffered dearly from it because I have moved 4 times in 2 years and my mail has been so messed up.

I know it is my responsibility to make sure that my Florida Corporation is valid and I do apologize that this has not been taken care of. I thought that it was reinstated because I sent in the report last year and paid the required \$158.75. The check cleared my bank so I did not think there was a problem. I did not know any letter had been sent that I needed to sign and return until I called to request the Certificate that I did not receive. I have attached correspondence that I sent last year for your review.

The reason for this letter is because I was told on the phone that I would have to pay a lot of money to reinstate my Corporation but if I wrote an explanation of what has happened then there might be some consideration given to me. If there is anything you can do to help me without me having to pay those large fees, I would really appreciate it. My company is still struggling to survive after everything that's happened in these past 2 years. I am finally separated from my husband and have my business in a new location, so things are starting to get better. Once I can get my Corporation back into a positive status then things will really be looking up!

I have enclosed the required form for reinstatement, along with a check in the amount of \$158.75. Thank you for anything you can do to help me through this.
