This certificate of incorporation may be amended in any manner with the laws of the State of Florida.

ARTICLE IX - OFFICERS

The officers of the corporation until the first meeting of the corporation Board of Directors, or until successors are elected. shall be: BEHNARD BENZAKI - PRESIDENT, SECHETARY, TREASURER

This corporation shall be initially deverned by the stockholders. notwithstanding other provisions of these Articles of Incorporation.
