
I am in receipt of your letter dated January 2, 2003 to Thomas L. Black and Gerard M. Hayden regarding the filing of Towne's Uniform Business Report ("UBR") with the Florida Secretary of State.

Per my conversation today with your legal assistant, Diane Haines, the filing of this UBR is an error that should be easily rectified by filing a 2003 UBR report and correcting the changes.

Our company, Private Business, Inc., (a Tennessee corporation) completed a merger with Towne Services, Inc. (a Georgia corporation) on August 9, 2001. The mailing address of the company was changed with the Florida Secretary of State shortly after the merger, so the Secretary of State mailed the UBR to our address. We mistakenly filed it thinking that it was for our subsidiary. Now, after receiving your letter and talking with the Secretary of State, we understand that the UBR that we received is for Towne Services, Inc., (a Florida corporation) which apparently is your client's company.
