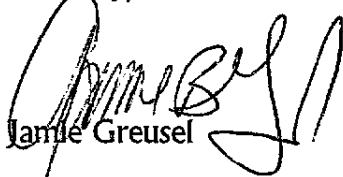

ARTICLES OF INCORPORATION
OF

X. AMENDMENTS

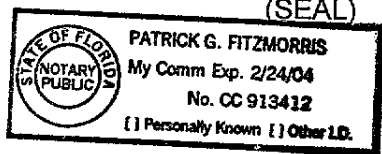

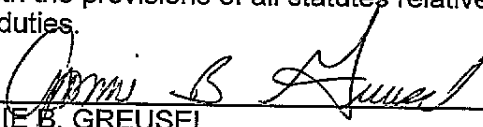
