**ARTICLES OF INCORPORATION**

**ARTICLE I**

The name of the corporation shall be:

**ARTICLE II**

1. The maximum number of shares of stock which this corporation is authorized to have outstanding at any time shall be five hundred (500) shares of common stock having \$1.00 par value.

The corporation shall indemnify any officer or director or any former officer or director, to the full extent of the law.


**ARTICLE XIII**



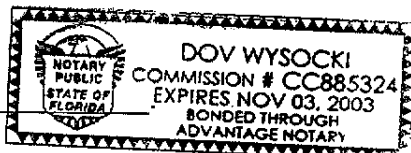


