ARTICLES OF INCORPORATION

OF

THE NEW AMERICAN WEEKLY PRESS, INC.

ARTICLE I

The name of this corporation is: **THE NEW AMERICAN WEEKLY PRESS, INC.**

ARTICLE II

The term of existence of the corporation is perpetual.

ARTICLE III

This corporation is organized for the following purposes:

- A. To publish a newspaper and to develop a better community through economic development.
- B. To own property, enter into contracts, and to carry on any business necessary or incidental to the accomplishment or furtherance of the purpose or objects of this corporation.
- C. The professional services of this corporation shall be carried out only through officers, employees, and agents, each of whom has experience in the newspaper business.
- D. Any and all other lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of \$10,000.00, par value common stock.

ARTICLE V - PRE EMPTIVE RIGHTS

Each shareholder upon the sale for cash of any new stock of this corporation of the same kind, class or series of that which he already holds, shall have the right to purchase his pro rata share (as nearly as may be done without issuance of fractional shares) at the price of which it is offered to others.

ARTICLE VI - INITIAL REGISTERED OFFICE AGENT

The street address of the initial registered office of this corporation is 619 N. Devilliers Street, Pensacola, Florida 32501, and the name of the initial registered agent of this corporation at

that address is Angelena LeRoy. The mailing address of this corporation is P.O. Drawer 13626, Pensacola, Florida 32591.

ARTICLE VII - INITIAL BOARD OF DIRECTORS

This corporation shall have five directors, initially. The number of directors may be either increased or diminished from time to time by the By-Laws, but shall never be less than five. The names and addresses of the initial directors of this corporation are:

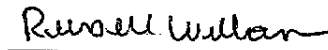

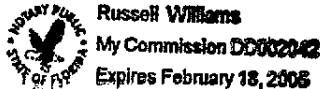
