The name of this corporation shall be ALLIANT TAX CREDIT XVII, INC.

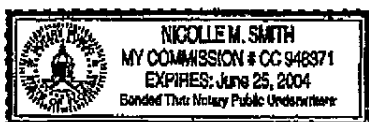
