The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation, under the laws of the State of Florida.

ARTICLE I - NAME

ARTICLE II - NATURE

The nature of the business to be transacted by this corporation is: hotel consulting, casino consulting, general real estate development.
