The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation, under the laws of the State of Florida.

<u>ARTICLE I - NAME</u>

ARTICLE II - NATURE

The nature of the business to be transacted by this corporation is: general remodeling. To erect dwellings, apartment houses and other buildings, private or public, of all kinds, and to sell or rent the same.
