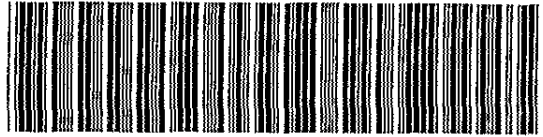

I, the undersigned, President and Secretary of Home Professionals of S.W. Florida, Inc., a corporation recognized under the laws of the State of Florida, hereby certify:


1. The name of the corporation is Home Professionals of S.W. Florida, Inc.;
2. The Articles of Incorporation are amended by the following resolution adopted by the Shareholders on September 22, 2003.


