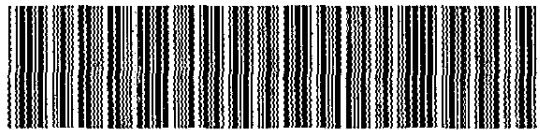

ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
CUPON LATINO, INC.

The undersigned, Jacqueline Edsis, sole member of the Board of Directors of Cupon Latino, Inc., a Florida corporation, organized and existing under and by virtue of the Florida Business Corporation Act (the "Corporation"), does hereby certify that

1. The name of the Corporation is CUPON LATINO, INC. document number P0100070907.
2. The following provisions of the Articles of Incorporation of the Corporation are amended as follows:

ARTICLE V.

CAPITAL STOCK

The Corporation shall have the authority to issue 10,000,000 shares of common stock, no par value.

ARTICLE VIII.

The corporation expressly elects not to be governed by Section 607.0901 and 607.0902 of the Florida Business Corporation Act.

3. In accordance with Section 607.0123(1)(b) of the Florida Business Corporation Act, this amendment shall be effective upon its filing with the Florida Department of State.
4. The foregoing amendment was adopted the Corporation's Board of Directors pursuant to the Florida Statutes. The foregoing amendment was approved by the shareholders of the Corporation pursuant to the Florida Statutes. The numbers of votes cast for the foregoing amendment was sufficient for approval.
5. Except as modified hereby, the Articles of Incorporation of the Corporation shall remain in full force and effect.

IN WITNESS WHEREOF, CUPON LATINO, INC., has caused this Articles of Amendment to the Articles of Incorporation to be executed by the undersigned duly authorized officers and attorney-in-fact of the Corporation.
