**ARTICLES OF INCORPORATION  
OF  
MID-SOUTH FINANCIAL MANAGEMENT CORPORATION**

**ARTICLE I**

**Name and Duration**

The name of the Corporation is Mid-South Financial Management Corporation. The duration of the Corporation is perpetual. This Corporation shall begin its corporate existence as of the date that these Articles are filed by the Secretary of State.

**ARTICLE II**

**Principal Office**

**ARTICLE III**

2. In furtherance of its corporate purposes, the Corporation shall have all of the general and specific powers and rights granted to and conferred on a corporation by the Florida Business Corporation Act.
