ARTICLE I NAME

THE NAME OF THIS CORPORATION IS

CONTRACT FURNITURE SOLUTIONS, INC.

ARTICLE II TERM OF CORPORATE EXISTENCE

THIS CORPORATION SHALL EXIST PERPETUALLY UNLESS DISSOLVED
ACCORDING TO LAW AND SUCH EXISTENCE SHALL COMMENCE AT THE
TIME OF FILING OF THESE ARTICLES OF INCORPORATION BY THE
DEPARTMENT OF STATE.

ARTICLE III CORPORATE PURPOSE

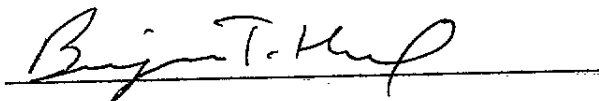
