ARTICLES OF INCORPORATION

OF

PHILBROOK DEVELOPMENT, INC.

Article 1. Name

The name of the Corporation is:

Philbrook Development, Inc.

Article 2. Duration

The duration of the Corporation is perpetual.

Article 3. Purposes

The general purposes for which the Corporation is organized are the following:

- A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida Business Corporation Act; and


