The undersigned hereby organizes a corporation for profit under the provisions of the Florida Business Corporation Act, and pursuant to the following Articles of Incorporation.

**ARTICLE 1**

**Name**

The name of this corporation is: Dorece G. Norris, M.D., P.A.

**ARTICLE 2**

**Nature of Business**

The general nature of business to be transacted by the corporation shall be to engage in every aspect of the practice of medicine. The professional service involved in the corporation's practice of medicine may be rendered only through its officers, agents and employees who are duly authorized and registered to practice medicine in the State of Florida.

**ARTICLE 3**

**Principal Address / Mailing Address**

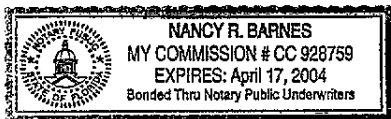
