NAME

The name of the Corporation is LANDSTAR SURVEYING OF NORTH  
FLORIDA, INC.

ARTICLE II

DURATION



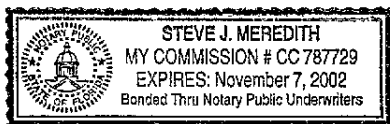


