The undersigned incorporator delivers these Articles of Incorporation in order to form a corporation under the Florida Business Corporation Act.

**ARTICLE 1**

Name

The name of the Corporation shall be STEGARCIA US, Inc.

**ARTICLE 2**

Principal office

The principal office of the corporation is located at 609 East Pine Street, Orlando, FL 32801, and its mailing address is the same.


