

ARTICLE I - NAME

The name of this corporation is FLORIDA MOTORCYCLE TOUR COMPANY.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE III - DURATION

This corporation shall have perpetual existence, commencing upon the 13th day of July, 2001
being the same date as the subscription to and acknowledgment of these Articles of Incorporation.

ARTICLE IV - PURPOSE

This corporation is formed for the purpose of transacting any and all lawful business not





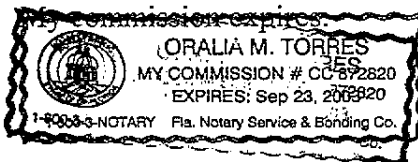
