

ARTICLE I - NAME

The name of this corporation is FLORIDA MOTORCYCLE TOUR COMPANY.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE III - DURATION

This corporation shall have perpetual existence, commencing upon the 13th day of July, 2001




