ARTICLES OF INCORPORATION

The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act and Professional Service Corporation Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation shall be:

J.C.I. ECO SOLUTIONS, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business/ mailing address is:

ARTICLE III - PURPOSE

The purpose for which the corporation is organized is for transacting any and all lawful business, including rental and operation activities related to real property authorized and not prohibited by the Florida General Corporation Act, as the same may be from time to time amended.

ARTICLE IV - SHARES

This corporation is authorized to issue six hundred (600) shares of capital stock, which shall be designated Common Shares with a par value of one dollar and no cents (\$1.00). The Directors of the Corporation are authorized and empowered to issue the capital stock of the corporation, as they in their discretion shall determine.

ARTICLE V - INITIAL DIRECTORS

- a. This corporation shall have three (3) directors initially.
- b. The number of directors of this corporation may be increased or decreased from time to time pursuant to By-Laws adopted by the Shareholders, but shall never be less than one (1).

Every shareholder, upon the sale for cash of any new stock in this Corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without the issuance of fractional shares) at the price at which it is offered to others.

ARTICLE XII - DURATION

This corporation shall begin its existence as of the filing of these Articles of Incorporation and shall exist perpetually unless dissolved by operation of law.

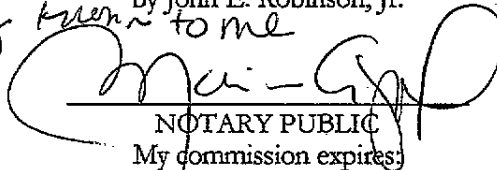

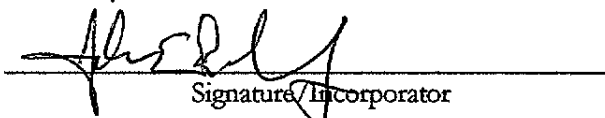
