ARTICLES OF INCORPORATION

OF

ADVANCED ENERGY SYSTEM, GROUP, INC.



THE UNDERSIGNED do hereby associate themselves for the purpose of forming a corporation under the laws of the State of Florida, and do hereby certify as follows:

ARTICLE I - NAME

The name of the Corporation shall be:

ADVANCED ENERGY SYSTEM, GROUP, INC.

ARTICLE II - PURPOSE

- A.- To carry on and engage Consulting Services domestically and abroad in any business activity.
