ARTICLES OF INCORPORATION

ARTICLE I – NAME

The name of the corporation shall be Robin Lemke-Fasulo, Inc.

ARTICLE II – PRINCIPLE OFFICE

ARTICLE IX – INDEMNIFICATION


The corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.


