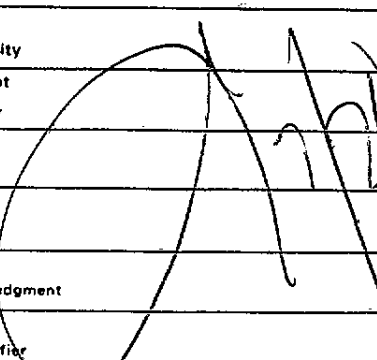

ARTICLE I - NAME

The name of the Corporation is **CENTURY RECYCLING OF FLORIDA, INC..**

ARTICLE II - ADDRESS

The principal office, or mailing address of the Corporation is 650 University Drive, Coral Gables, Florida 33134.

ARTICLE III - DURATION

This Corporation shall have perpetual existence.

ARTICLE IV - PURPOSE
