# ARTICLES OF INCORPORATION

# NISHA ENTERPRISES, INC.

OJ JUL 19 PM 1:30 The undersigned incorporator, for the purpose of formings corporation under the Florida Business Corporation Act, here adopts the following Articles of Incorporation.

#### ARTICLE I

# NAME, PRINCIPAL PLACE OF BUSINESS AND DURATION

The name of the Corporation is NISHA ENTERPRISES, INC. The principal place of business of the Corporation is 1402 WURST ROAD, OCOEE, FL. 34761. The duration of the Corporation is perpetual.

#### ARTICLE II
